08.00 - 11.00	Companionship, breakfast preparation, light exercises, personal care and housework.
13.00 - 15.00	Lunch preparation, clear-up and card games, crosswords, other indoor activities.
17.30 - 18.30	Dinner preparation, medication reminder, tidy up after meal.
20.00 - 21.00	Personal care, assist to bed, companionship.
